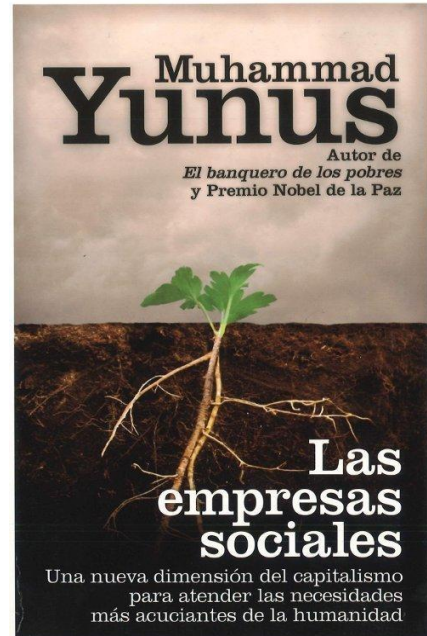

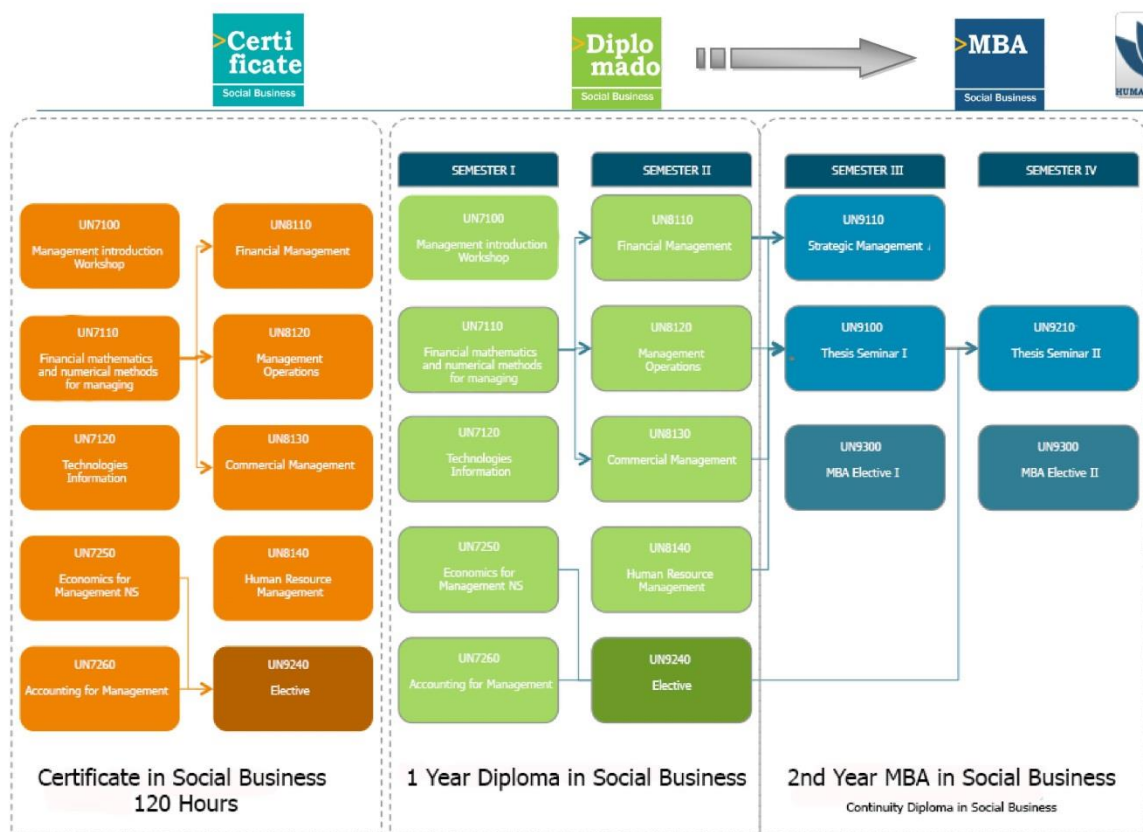

Constitution

The SBS is responsible for supporting the universities throughout the process of establishing schools:

- Giving the full basic content of curricular programs to them, the university must accommodate to their standards
- Basic Training and training teachers from or the university to teach the courses
- Providing and imparting knowledge about social business and Social Solidarity Economy
- Supporting the development and understanding of the financial model of the business school

Operations and Infrastructure

All operations necessary for the operation of the School of Social Business is the responsibility of the University, as well as the provision of adequate infrastructure. The following responsibilities are specified apriori

Financial Model and Social Funds

The school will operate as a social business, where financial transactions will be conducted by the University itself a social fund for scholarships and to donate and/or to manage projects supporting the development of the community. Moreover, the SBS board will ensure the transparency of these: (agreement must be signed to determine percentages)

- 75% of the revenues of the School of Social Business should be reinvested in this same school and programs, funds, to cover: Payroll professors, teachers, administrative staff, Directors, payments, among other possible investments that support the effective management of it.
- 25% of the remaining income is net earnings of the University, for use of facilities which each university has a free option on the use of this percentage
